 - Motion to recommend to the endorsement committee to put both candidates (I. Perkel and D. Orange) on the agenda for the September meeting to vote on for recommendation. Moved by Charles Polacek, seconded by Susan Schwartz. Motion discussed. Motion withdrawn
 - Motion to hold Special Meeting on August 26th to discuss candidate recommendations for the races for Port Comissioner and City Council as well as other recommendations. Moved by Charles Polacek, seconded by Susan Schwartz. Motion discussed. Motion passed 24 in favor, 5 against, total present 40. Motion passed
