# **Background**

Pursuant to our bylaws, the Endorsements and Recommendations Committee has the following recommendations for endorsement.

10.02.1 In a partisan primary election in which two (2) or more Democrats are running, the CCDCC may endorse the candidacy of any person for public office. Individual members may also do so, but shall not state or imply that this is in their capacity as elected party officers.

10.02.2 CCDCC endorsement of a partisan candidate shall be made by a formal motion of endorsement approved by a majority vote at a regularly scheduled meeting.

The Endorsements and Recommendations Committee recommends the following endorsements. We will seek a separate motion on each of these recommendations, followed by two statements for, two against, and vote on each separate motion.

- a. Seek a motion endorsing Marie Gluesenkamp Perez for Congress
- b. Seek a motion endorsing Bob Ferguson for Governor
- c. Seek a motion dual endorsing Manka Dhingra and Nick Brown for state Attorney General
- d. Seek a motion endorsing Joe Biden for President, Maria Cantwell for US Senate, Denny Heck for Lt. Governor, Chris Reykdal for Superintendent of Public Instruction, Steve Hobbs for Secretary of State, Annette Cleveland for State Senator, Sharon Wylie for State Representative, and Monica Stonier for State Representative.
- e. Additional endorsement recommendations may be brought to future meetings by the Endorsements and Recommendations Committee
