Under our bylaws, the Endorsements and Recommendations Committee has the following recommendations for endorsement.

10.02.1 In a partisan primary election in which two (2) or more Democrats are running, the CCDCC may endorse the candidacy of any person for public office. Individual members may also do so, but shall not state or imply that this is in their capacity as elected party officers.

10.02.2 CCDCC endorsement of a partisan candidate shall be made by a formal motion of endorsement approved by a majority vote at a regularly scheduled meeting.
